

QUARTERLY REPORT – JUNE 2018

Australian based iron ore development company, Kogi Iron Limited (ASX: KFE) (“Kogi”, “Kogi Iron”, or the “Company”) and its 100% owned Nigerian operating company, KCM Mining Limited (“KCM”) presents the quarterly activity report for the three months ended 30 June 2018.

Key activities by the Company during the quarter were:

PROJECT TESTWORK PROGRAM PROGRESSED

Metallurgical testwork associated with the commercialisation of the Agbaja oolitic iron ore deposits in Kogi State, Nigeria continued in the quarter. Activity levels were slower than anticipated due to the impact of the recently completed Section 249D process.

The testwork program involves four distinct stages:

1. Bulk Sample Preparation and Beneficiation
2. Smelting
3. Refining
4. Process Modelling and Reporting

The Refining testwork continued during the quarter to June. Refining testwork focused on confirming the reproducibility of the initial results and to optimise conditions for further refining. Additional supplies of reagent materials were required to conduct enhanced bulk refining testwork and these were delivered and testwork by Mintek recommenced.

In conjunction, chemical and moisture analysis on the two locally sourced (Nigerian) coal samples continues to progress in the Torex laboratories in Russia. This will be followed by rotary kiln testing. The company awaits the results of these tests which are expected shortly.

CORPORATE

The Company issued 29,800,000 shares following the exercise of all of the unlisted options that were on issue with an exercise price of \$0.0305 each and expiry date of 30 November 2019; raising \$908,900.

The Company held a General Meeting on 2 July 2018 following a Notice Pursuant to Section 249D of The Corporations Act. The majority of shareholders voted to maintain the current board. Mr Kevin Joseph resigned

as director of Kogi in early July. Kogi has commenced the process of identifying a suitable replacement to oversee the Company's Nigerian operations.

At the end of the quarter, the Company had cash at bank of \$2,361,000.

About Kogi Iron (ASX: KFE)

Kogi Iron Limited is a Perth-based company with the objective of becoming a producer of cast steel product that can be sold to manufacturers of steel products through the development of its 100% owned Agbaja Cast Steel project located in Kogi State, Republic of Nigeria, West Africa ("Agbaja" or "Agbaja Project").

Nigeria has substantial domestic demand for steel products, which is currently met largely through imports. The Agbaja project, located on the Agbaja plateau approximately 15km northwest of Lokoja city in Kogi State and approximately 200km southwest of Abuja, the capital city of Nigeria, opens the opportunity for domestic production of steel billets.

The Company holds a land position which covers a large part of the Agbaja Plateau. The Agbaja Plateau hosts an extensive, shallow, flat-lying channel iron deposit with an Indicated and Inferred Mineral Resource of 586 million tonnes with an in-situ iron grade of 41.3% reported in accordance with the JORC Code (2012). This mineral resource covers approximately 20% of the prospective plateau area within ML24606 and ML24607.
