Notice Under Section 708A(5)(e) of the Corporations Act

Kogi Iron Limited (ASX: KFE – the “Company” or “Kogi”) today issued and allotted 20,000,000 fully paid ordinary shares (“Securities”) as a private placement to sophisticated investors at 10 cents per share to raise \$2,000,000 (before costs), as announced on 5 February 2018.

Secondary Trading Exemption:
