Kogi Iron Limited (ASX: KFE – the “Company” or “Kogi”) today issued and allotted 6,773,529 fully paid ordinary shares in the capital of the Company (“Shares”) as a private placement to sophisticated investors at 8.5 cents per share to raise \$575,750 (before costs), as announced on 1 February 2019.

Below is the applicable Cleansing Notice.

#### **Secondary Trading Exemption:**
