

### **Notice Under Section 708A(5)(e) of the Corporations Act**

Kogi Iron Limited (ASX: KFE – the “Company” or “Kogi”) today issued and allotted 821,002 fully paid ordinary shares in the capital of the Company (“Shares”) in lieu of payment for professional services provided to the Company by consultants as per the attached Appendix 3B.

Below is the applicable Cleansing Notice.

#### **Secondary Trading Exemption:**
